Summarv

When Airport Management Services (AMS) inspected the Wiluna Airport runway in 2005 they told Council that a reseal would be required within the next 12-18 months.

Background

Since that recommendation was made the Shire of Wiluna has sought a recommendation from CASA for an engineer to give us another opinion on the state of the runway. That report is from Enesar attached.

Engineer's and Consultant's Comments

- (1) The engineer's summary of what he found is as follows:
 "The seal is old very brittle and has suffered cracking and breaking up throughout the entire runway". The engineer has also recommended that the central area of the runway should be cement stabilised and then the runway resealed.
- (2) AMS recommended a total reseal only.

Consultation

There has been consultation through all of this with AMS and Enesar as well as with CASA.

Statutory Environment

Local Government (Functions and General) Regulation 11 (f) says that a tender does not have to be called if "the Local Government has good reason to believe that, because of the unique nature of the goods or services required or for any other reason, it is unlikely that there is more than one potential supplier".

Most of the services required are supplied by one company only.

The consultant has assured me that whilst there are more than one company who can supply the resealing of the runway there is only one large company prepared to take on the work immediately and who will be in the area at the time and thus saving on costs.

Policy Implications

The main policy concern for the Shire of Wiluna is that the runway is safe. The second concern is that the money is not spent in such a way that would mean further repairs in one or two years and that we get a lasting result.

Summary

This alteration to the budget is to pay for the upgrade of the runway at the Wiluna airport.

Background

During the annual inspection of the runway in 2005 Airport Management Services warned the Shire that the runway required a reseal within the next 12-18 months and that it would cost at least \$225,000.

The Shire of Wiluna engaged an engineer recommended by CASA to inspect the runway and he found is as follows:

"The seal is old very brittle and has suffered cracking and breaking up throughout the entire runway". The engineer has also recommended that the central area of the runway should be cement stabilised and then the runway resealed.
